AMENDMENT NO. 3 TO SCHEDULE 13G

This Amendment No. 3 to Schedule 13G is filed by Mitchell Jacobson ("Mr. Jacobson") to amend and restate in its entirety the Schedule 13G, originally filed on February 14, 1996, as amended by Amendment No. 1, filed on February 17, 2004 and Amendment No. 2, filed on February 10, 2005, with respect to the Class A Common Stock (as defined below) of MSC Industrial Direct Co., Inc. (the "Company").

This Amendment No. 3 reflects shares beneficially owned by Mr. Jacobson and shares of the Company outstanding as of January 3, 2006.

Jacobson 2005 Grantor Retained Annuity Trust #2 ("GRAT 2"), of which Mr. Jacobson is the settlor and trustee; (iii) 7,650,706 shares of Class B Common Stock, par value \$.001 per share, that are convertible into shares of Class A Common Stock on a one-to-one basis (the "Class B Common Stock"), held by Mr. Jacobson; (iv) 200,000 exercisable options to purchase shares of Class A Common Stock held by Mr. Jacobson; (v) 1,100,000 shares of Class B Common Stock held by the GRAT 2; (vi) 3,000,000 shares of Class B Common Stock held by the Mitchell L. Jacobson 2005 Grantor Retained Annuity Trust, of which Mr. Jacobson is settlor and trustee;

and (vii) 946,246 shares of Class B Common Stock held by the Marjorie Diane Gershwind 1994 Qualified Fifteen Year Annuity Interest Trust, of which Mr. Jacobson is the sole trustee. Mr. Jacobson disclaims beneficial ownership of all the shares of Class A Common Stock and Class B Common Stock owned by the GRAT 2, all the shares of Class B Common Stock owned by the Mitchell L. Jacobson 2005 Grantor Retained Annuity Trust and all the shares of Class B Common Stock owned by the Marjorie Diane Gershwind 1994 Qualified Fifteen Year Annuity Interest Trust.

Based on calculations made in accordance with Rule 13d-3, and there being approximately 46,798,823 shares of Class A Common Stock outstanding (as reported by the Company in its Quarterly Report on Form 10-Q for the fiscal quarter ended November 26, 2005), Mr. Jacobson may be deemed to beneficially own approximately 21.9% of the outstanding Class A Common Stock.
