AMENDMENT NO. 4 TO SCHEDULE 13G

This Amendment No. 4 to Schedule 13G is filed by Marjorie Gershwind ("Ms. Gershwind") to amend and restate in its entirety the Schedule 13G, originally filed on February 14, 1996, as amended by Amendment No. 1, filed February 17, 2004, Amendment No. 2, filed February 10, 2005 and Amendment No. 3, filed January 23, 2006, with respect to the Class A Common Stock (as defined below) of MSC Industrial Direct Co., Inc. (the "Company").
