Three Questions to the CEO – Interview with Aldo Belloni on the proposed merger

The Linde Group released its 2016 financial results today, 9 March 2017. In this short interview, Prof. Aldo Belloni provides an insight into Linde's priorities and the current status of the negotiations with Praxair.

Three questions to the CEO

What are Linde's business priorities for 2017?

Let us first look back at our performance in 2016 which was an eventful year for Linde, in every respect. In a persistently challenging economic environment we were once again able to deliver a solid performance, thus meeting our expectations for the year. Both Group revenue and operating profit grew on a currency-adjusted basis. We increased our profitability versus revenues at the Group and the Gases Division levels, while delivering a margin in Engineering in line with expectations. The second part of our HPO programme, which ran from 2013 to 2016, has been successfully completed. And the initial impact of our global LIFT programme is visibly enhancing efficiency in the regions where measures have already been implemented.

As for 2017, we expect the challenges of the past years to continue, including political uncertainty, difficult conditions for many regional economies and industry sectors, high price pressure and an aggressive competition from low-cost rivals.

We have nevertheless confirmed our financial outlook for 2017. With regard to our priorities, this means staying the course, driving LIFT forward and carry on with continuous efficiency improvement in our daily activities. In parallel we must also continue to pursue opportunities for sustainable, profitable growth. In today's uncertain economic environment, it is not enough for long-term business sustainability to merely be successful at what we do now. For us, this means striving for growth in new and existing markets but also embracing digitalisation to improve our products, services and processes.

How can a merger with Praxair make Linde a stronger company?

First and foremost, allow me to emphasise that Linde is already a strong company with a fundamentally stable business model. We offer competitive solutions and promising innovations and are looking at the right things: We focus on our strengths – but also know where we need to improve.

However, our goal is not only to be strong today, but to grow and remain strong in the future. As just described, this is a difficult proposition in the competitive markets where we are active. Global economic trends will continue to be affected by multiple risks and uncertainties and growth of global industrial production could also further slow down as a result.

Adding Praxair's business to our own would strengthen our ability to achieve our goal in the face of these challenges. We are operating in a market where scale is increasingly a prerequisite for companies to improve their cost position, for example in procurement and supply chain management. The resilience and financial strength of the combined company would also allow us more flexibility for "mega investments" in new projects.

A broader, more global business would also open up both local and international opportunities for our employees. After all, a more competitive and innovative company is also a prerequisite for job security and could create attractive new positions. In summary: combining our strengths, assets and talents with those of Praxair would not only help us become a clear leader in the industrial gases industry but also help us safeguard a leading position in the long run.

Where do we stand now in the negotiation process?

Highly qualified people from both companies have been collaborating since January to put together the binding Business Combination Agreement. Specific work streams have been established to analyse topics ranging from synergies to antitrust issues. We have made good progress and aim to sign and announce the BCA in advance of our annual general meeting on 10 May. Rest assured that we will inform everyone as soon things are clearer and when we are legally able to communicate any changes.

Should Praxair, Inc. (“Praxair”) and Linde AG (“Linde”) proceed with the proposed business combination transaction, Praxair and Linde expect that a newly formed holding company (“New Holdco”) will file a Registration Statement on Form S-4 or Form F-4 with the U.S. Securities and Exchange Commission (“SEC”) that will include (1) a proxy statement of Praxair that will also constitute a prospectus for New Holdco and (2) an offering prospectus of New Holdco to be used in connection with New Holdco’s offer to acquire Linde shares held by U.S. holders. When available, Praxair will mail the proxy statement/prospectus to its stockholders in connection with the vote to approve the merger of Praxair and a wholly-owned subsidiary of New Holdco, and New Holdco will distribute the offering prospectus to Linde shareholders in the United States in connection with New Holdco’s offer to acquire all of the outstanding shares of Linde. Should Praxair and Linde proceed with the proposed business combination transaction, Praxair and Linde also expect that New Holdco will file an offer document with the German Federal Financial Supervisory Authority (Bundesanstalt fuer Finanzdienstleistungsaufsicht) (“BaFin”). There can be no assurance that a binding definitive agreement will be reached between Praxair and Linde, and the consummation of any binding transaction will be subject to regulatory approvals and other customary closing conditions.
