On March 16, 2005, Alamosa Holdings, Inc. ("Alamosa") completed a private exchange transaction pursuant to which a holder of Alamosa's Series B Convertible Preferred Stock, par value \$0.01 per share ("Preferred Stock"), delivered to Alamosa 30,807 shares of Preferred Stock in exchange for 2,323,754 newly issued shares of Alamosa's common stock, par value \$0.01 per share. The shares of common stock issued in exchange for the Preferred Stock were exempt from the registration requirements of the Securities Act of 1933 pursuant to Section 3(a)(9) thereunder.
