Item 2.02. Results of Operations and Financial Condition.

On August 12, 2015, Kingstone Companies, Inc. (the “Company”) issued a press release (the “Press Release”) announcing its financial results for the fiscal period ended June 30, 2015. The Press Release also announced that the Company’s Board of Directors has declared a \$.05 per share quarterly dividend payable on September 15, 2015 to stockholders of record as of the close of business on August 31, 2015. Item 5.07. Submission of Matters to a Vote of Security Holders.

On August 11, 2015, the Company held its Annual Meeting of Stockholders (the “Annual Meeting”). The following is a listing of the votes cast for or withheld, and the number of broker non-votes, with respect to each nominee for director and a listing of the votes cast for and against, as well as abstentions and broker-non votes, with respect to the other matters voted upon at the Annual Meeting. The Company’s stockholders elected each of the nominees as a director, approved the Company’s 2014 Equity Participation Plan and ratified the selection of Marcum LLP as the Company’s independent registered public accounting firm for the fiscal year ending December 31, 2015.
