On June 14, 2013, Air Lease Corporation (the Company) entered into a non-binding memorandum of understanding with The Boeing Company (Boeing). Pursuant to the non-binding memorandum of understanding, the Company agreed to purchase 33 aircraft from Boeing comprised of three 787-9 and 30 787-10X Dreamliners. Deliveries of these aircraft are scheduled to commence in 2019 and to continue through 2023.

The Company and Boeing issued a joint press release on June 18, 2013 announcing the non-binding memorandum of understanding. A copy of the press release is filed as Exhibit 99.1 hereto and incorporated herein by reference.
