

#### Item 8.01 Other Events.

On December 16, 2015, Rite Aid Corporation ( Rite Aid ) issued a press release, a copy of which is attached hereto as Exhibit 99.1, announcing that it has established a record date of December 18, 2015, and a meeting date of February 4, 2016, for a special meeting of its stockholders to, among other things, consider and vote on a proposal to approve the previously announced Agreement and Plan of Merger, dated as of October 27, 2015 (the Merger Agreement ), by and among Rite Aid, Walgreens Boots Alliance, Inc., a Delaware corporation ( WBA ), and Victoria Merger Sub, Inc., a Delaware corporation and a wholly owned direct subsidiary of WBA ( Victoria Merger Sub ), providing for the merger of Victoria Merger Sub with and into Rite Aid (the Merger ), with Rite Aid surviving the Merger as a wholly owned direct subsidiary of WBA.
