(1) The reporting person's holdings include 329.23 shares acquired under the issuer's dividend reinvestment and common stock purchase plan since the reporting person's last report. These shares were acquired pursuant to the employee stock purchase plan provisions of the dividend reinvestment and common stock purchase plan, which acquisitions are exempt from Section 16.

(2) Includes 171.49 shares acquired via dividend reinvestment on December 28, 2012 at \$30.28 per share.

(3) The reporting person's holdings include 144.46 shares acquired under the issuer's dividend reinvestment and common stock purchase plan since the reporting person's last report.
