(1) Received gift of 704 MUR shares on 8/12/2013. On August 30, 2013, Murphy Oil Corporation (MUR) distributed to its stockholders one share of the Issuer's common stock for every 4 shares of MUR common stock outstanding as of 4:00 p.m. EST on August 21, 2013, the record date for the distribution. The reported shares were issued in respect of shares of MUR common stock held by the reporting person as of such record date.

(2) These Common Shares are held in the Estate of William C. Nolan, Jr. (the "Estate"). The reporting person is one of three executors of the Estate and is a 1/3 beneficiary of the Estate. The reporting person disclaims beneficial ownership of the additional 2/3 of these Common Shares.
