("Goldman Sachs") and The Goldman Sachs Group, Inc. ("GS Group") are the general partner, managing general partner or managing limited partner ("Limited Partnerships").

(3) Reflects a weighted average sale price of \$29.5825 per share, at prices ranging from \$29.50 to \$29.68 per share.
