In connection with the announcement that Esterline Technologies Corporation, a Delaware corporation (the Company ), entered into an Agreement and Plan of Merger (the Merger Agreement ) with TransDigm Group Incorporated, a Delaware corporation ( Parent ), and Thunderbird Merger Sub Inc., a Delaware corporation and wholly owned subsidiary of Parent ( Merger Sub ), on October 17, 2018, the Company distributed the following materials to its employees, the full text of which is attached hereto as Exhibit 99.1 and Exhibit 99.2 and incorporated herein by reference:
