- These restricted stock units are subject to achievement of specified Company common stock prices during the period September 21, 2016 through May 31, 2019 (the "Performance Period) and, if achievement is met, vest 50% on September 21, 2020 and 50% on September 21,
- (1) 2021. Achievement varies from 0% to 120% of target depending on the volume-weighted average price over any consecutive 150-calendar days during the Performance Period as follows: less than \$7.00 = 0% of target, \$7.00 = 25% of target, \$7.50 = 50% of target, \$8.00 = 100% of target, and \$10.00 or greater = 120% of target.
  - (2) These restricted stock units are issued under Sprint Corporation's 2015 Omnibus Incentive Plan. Each unit represents the right to receive one share of the underlying security at a date in the future.
