**Item 5.02 Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; Compensatory Arrangements of Certain Officers.**

As a result of the reorganization of the marine operations of Brunswick Corporation ("Brunswick") described below in Item 8.01, Peter B. Hamilton will retire as Vice Chairman of the Board of Directors and President - Brunswick Boat Group effective January 31, 2007.

**Item 8.01 Other Events.**

On January 18, 2007, Brunswick announced a new organizational structure to advance the integration of its marine operations. Under the new structure, the heads of Brunswick's boat divisions will report to Dustan E. McCoy - Chairman and Chief Executive Officer. In addition, Patrick C. Mackey has been named Executive Vice President of Brunswick and Chief Operating Officer - Marine. Mr. Mackey will continue to serve as President - Mercury Marine Group. In his new role, Mr. Mackey will assume functional responsibility for a range of activities across Brunswick's marine operations.

A news release announcing the new organizational structure for Brunswick's marine operations and the retirement of Mr. Hamilton is attached hereto as Exhibit 99.1, and is incorporated herein by reference.
