These shares were acquired pursuant to a grant of restricted stock units on March 18, 2013 under the Amended and Restated XOMA

(1) Corporation 2010 Long Term Incentive and Stock Award Plan and are scheduled to vest in substantially equal installments on each of March 18, 2014, March 18, 2015, and March 18, 2016.

(2) Each restricted stock unit represents the right to receive, at settlement, one share of common stock. This nondiscretionary transaction represents the settlement of vested restricted stock units in shares of common stock.

These shares were acquired pursuant to a grant of restricted stock units on May 23, 2013 under the Amended and Restated XOMA

(3) Corporation 2010 Long Term Incentive and Stock Award Plan and are scheduled to vest in substantially equal installments on each of March 18, 2014, March 18, 2015, and March 18, 2016.
