- Pursuant to the Merger Agreement, each share of Issuer common stock issued and outstanding immediately prior to the effective time of (3) the Merger was converted at such time into the right to receive: (A) 0.37 shares of EQT common stock, and (B) \$5.30 in cash, without interest.
