If, within 5 days prior to any vote of stockholders, the Trustee has not received instructions from such participants with respect to any shares of stock in their accounts, the Trustee may vote such shares at such meeting in the same proportion as the shares for which the Trustee has received timely instructions, subject to applicable law. There are no conversion privileges for the preferred stock shares; however, the preferred stock shares have 10 voting rights to 1 voting right for common stock shares.

\*\*Shares of preferred stock in the Plan are held in various accounts, allocated by the source of contribution (employer, the predecessor to the employer or the employee) and may be disposed of by the Plan or the Trustee only in accordance with the terms of the Plan.
