DTE Energy Company (“DTE Energy”) will meet with investors at the EEI Financial Conference in Orlando, Florida on November 10 -12, 2013. Chairman of the Board, President and Chief Executive Officer Gerard M. Anderson will provide a business update to the EEI Financial Conference at approximately 11:15 a.m. EST November 12, 2013. A copy of the slide presentation from the meetings and the business update presentation is furnished as Exhibit 99.1 to this report and will be available on DTE Energy's website, www.dteenergy.com on November 8, 2013. The business update presentation will be available via live webcast and archived for future viewing through a link on DTE Energy's website, www.dteenergy.com. In the meetings and the presentation, DTE Energy reaffirms its 2013 operating earnings per share guidance of \$3.95-\$4.15 per share and tightens its 2014 early outlook operating earnings guidance range to \$4.15-\$4.39 per share from \$4.12-\$4.42 per share.

In its business presentation and this filing, DTE Energy discusses 2013 and 2014 operating earnings guidance. It is likely that certain items that impact the company's 2013 and 2014 reported results will be excluded from operating results. Reconciliations to the comparable 2013 and 2014 reported earnings guidance are not provided because it is not possible to provide a reliable forecast of specific line items. These items may fluctuate significantly from period to period and may have a significant impact on reported earnings.
