A Registration Statement was filed on July 11, 1996 (Registration No. 333-3258) (the <code>Prior</code> Registration Statement, to register under the 1933 Act shares of Canadian National Railway Company (the <code>Company</code>) common stock (the <code>Common</code> Stock, issuable under the Management Long-Term Incentive Plan (the <code>Plan</code>). This Registration Statement has been prepared and filed pursuant to and in accordance with the requirements of General Instruction E to Form S-8 for the purpose of effecting the registration under the 1933 Act of an additional 7,500,000 shares of Common Stock that have been issued or are issuable under the Plan at any time or from time to time.
